

6698 PDPL APPLICATION FORM OF THE DATA HOLDER

GENERAL EXPLANATIONS

Article 11 of the Personal Data Protection Law No. 6698 (PDPL) grants personal data owners, also known as data subjects, certain rights regarding the processing of their personal data. According to paragraph 1 of Article 13 of the PDPL, applications for these rights must be made to our Institution, which is the data controller.

- ✓ By hand, through a notary, the wet-signed application form together with a document that will provide confirmation of identity
- ✓ By signing with a secure electronic signature issued under the Electronic Signature Law No. 5070 or
- ✓ It must be communicated to us by one of the methods prescribed by the Personal Data Protection Board.
